QUESTIONS IF YOU WISH. IF YOU DECIDE TO ANSWER QUESTIONS NOW WITHOUT A LAWYER PRESENT, YOU WILL STILL HAVE THE RIGHT TO STOP ANSWERING AT ANY TIME. YOU ALSO HAVE THE RIGHT TO STOP ANSWERING AT ANY TIME UNTIL YOU TALK TO A LAWYER. DO YOU UNDERSTAND? YES OR NO?

DERRICK: YES SIR.

LT. WILLIAMS: AND YOU'RE STILL WILLING TO TALK?
