Title: DISORDERLY CONDUCT, RESISTING ARREST

Report Type: I

On 6-18 11, I officer Miron Smith along with other officers, were dispatched to 808 Ash St. in reference to someone trespassing with some coolers. When I arrived, I spoke with Mae Lou and her son Leland Lou and they stated, they were having a problem with the owner of the store around the corner on 407 Flower St. Riydah Fadel. Mae Lou stated that Riydah Fadel had two coolers on the Lou's property and they wanted them moved. Leland Lou stated at the time we were there, was the third time today police were called about the coolers. Leland Lou and Mae Lou both stated that Riydah Fadel asked the Lou's to give him about 25 minutes and he would have the cooler off his property. When officers went to the area where the coolers were, Tin Lou was standing behind the store near a power chair, of Riydah Fadel's store but on his own property. Sgt. L.V. Archie came to the area and tried to reason with the Lou's by asking Riydah Fadel, "How long will it take for you to get the cooler off the Lou's property?" Riydah Fadel said about 25 minutes once he get the guys that were helping him back. Riydah Fadel sent a message by someone to have the men come back and they did return. As the men were moving the cooler, Tin Lou rode his power chair up to the back of the back wall where the cooler was being taken in the building. Tin Lou stated that most of the property behind the store belongs to him (Tin Lou), all but approximately 3 feet, but the cooler is more than 3 feet wide and about 10 feet long. Tin Lou, Mae Lou, and Leland Lou were advised by Sgt. Archie to allow them the 25 minutes to get the cooler in the building and off his (Tin Lou's) property, and if the Lou's interfere, arrest them for disorderly conduct failure to comply by not allowing the cooler to be moved off his property.

I, officer Smith, asked the Lou's to back away so no one gets hurt and Tin Lou refused. Leland Lou was asked by me would he ask his father to move out of the way or he will be arrested. Leland Lou said, "we will not move and if you put your hands on me, I will call my lawyer and sue you." Tin Lou backed his power chair into the cooler as the men were holding it so it wouldn't turn over. I then stated to Leland Lou he was under arrest. I reached for Leland Lou's wrist to place my handcuffs on him and he pulled away from me and I instructed him do not resist. I then reached and grabbed Leland Lou wrist again, Mae Lou then hit me on my arm stopping me from placing my handcuffs on Leland Lou. I Then placed the handcuffs on Mae Lou and told her she was also under arrest. I then attempted to place handcuffs on Leland Lou again, and resisted again. I then told Leland Lou to stop resisting or he would be maced. He refused and continued to resist and was maced. In attempt to handcuff Leland Lou again, he resisted again and was taken to the ground by myself and officer Hawkins. One of the men stated to me that they have been trying for 4 hours to get the second cooler in the store but Tin Lou would not allow them to move the cooler and the men were asked to leave the property because they were trespassing.

Leland Lou and Mae Lou were taken in to custody and placed in my patrol car. Officer Lovell ask was Tin Lou being arrested also, I stated yes. Tin Lou then rode his power chair up to me and said, "You bad ass, you arrest me and I will sue your ass." Mae Lou was allowed to lock up her store. Leland Lou and Mae Lou were transported to the police station and Mae Lou was charged with disorderly conduct failure to comply, and Leland Lou was charged with disorderly conduct failure to comply and resisting arrest. Tin Lou was transported by officer Lovell and was charged with disorderly conduct failure to comply. Tin Lou complained of health problems and MEDSTAT was called to the police station and Tin Lou was transported to the hospital and was released less than 2 hours later and transported back to the police station by officer Lovell where the Lou family were at
