## PETITION TO CONTEST ELECTION

COMES NOW Petitioner Preston Ratliff, by and through his undersigned counsel, by and pursuant to MCA Section 23-15-921, et seq., and files this his Petition to Contest the August 2, 2011, Democratic Primary Election for the position of Leflore County, Mississippi, Supervisor District 3 and for cause will show as follows, to-wit:

- 1. That Petitioner Preston Ratliff, an adult resident citizen and a qualified elector of Supervisor District 3, of Leflore County, MS, duly qualified as a democrat for reelection as District 3 Supervisor.
- 2. That Petitioner was challenged by Respondent Anjuan Brown for District 3

  Supervisor in the Primary Election held on August 2, 2011.
- 3. That the Democratic Primary Election held on August 2, 2011, was conducted by the Leflore County Democratic Election Committee.
- 4. That after the tabulation and counting of the ballots, the Leflore County

  Democratic Executive Committee certified the election results in District 3 as follows:

607

5. That a breakdown of the votes for District 3 Supervisor was as follows:

- 6. That as a result of the above certification of the Election for said District 3
  Supervisor, the Leflore County Democratic Executive Committee declared Anjuan Brown as the winner by 89 marginal votes.
- 7. That petitioner contends that numerous irregularities, fraud and wilful violations of Mississippi Election Law occurred during the election and during the computation of the election results.
- 8. That the Leflore County Democratic Executive Committee counted illegal votes for Anjuan Brown and denied legitimate votes for your petitioner.
- 9. That the certification of the election result by the Leflore County Democratic Executive Committee is not the determined will of the voters for the District 3 Supervisor of Leflore County, MS during the Democratic Primary on August 2, 2011.
- 10. That a total of 292 absentee ballots, affidavit ballots, curbside and paper ballots were counted in District 3 by the Leflore County Democratic Executive Committee following the August 2, 2011, Primary Election.
- 11. That a total of 252 absentee ballots were counted in District 3 Supervisor race by the Executive Committee after the Primary with petitioner receiving 49 votes and respondent receiving 203 votes.
  - 12. That out of the 252 total absentee ballots cast and counted in District 3

Supervisor race, the applications for 153 of them revealed the voters would be "out of the county on election day."

13. That during the Primary Election on August 2, 2011, petitioner contends the following stated voters cast absentee ballots in favor of Respondent Anjuan Brown all in violation of Mississippi Laws governing absentee ballots as follows:

That during the campaign, respondent and his supporters Andrew Powell, Carl Winters, Lakeshia Stigler and Lacreshia Stigler, Kyle Scott and others engaged in fraudulent acts encouraging able bodied voters to cast absentee ballots by falsely and fraudulently checking on their applications that they would be "outside the county on election day."
- 15. That 152 of the 161 listed in paragraph 10 above, gave a fraudulent or wilful reason for casting ballots in the August 2, 2011, Democratic Primary Election. Based upon information and belief, an overwhelming majority of these voters voted for respondent.
- 16. That a total of eight voters casting ballots on August 2, 2011, failed to state a reason on their application for absentee ballots. (See #7, 14, 38, 58, 59, 61, 67 and 143 under paragraph number 10 above). Based upon information and belief, these votes were cast for respondent.
- 17. That there was no application for absentee ballot for Marcella Hicks, however his ballot was illegally and unlawfully opened and counted. Based upon information and belief, his vote was cast for respondent.

- 18. That numerous persons were allowed to cast absentee ballots although their application failed to substantially comply with Mississippi law governing absentee ballots.
- 19. That the applications for the absentee ballots of the following voters were substantially defected due to lack of the seal of the Circuit Clerk affixed to it and a lack of initial of the registrar or his deputy on the applications, namely:

- 21. That Viola Williams is a registered voter of District 4 but she was allowed to cast an illegal and unlawful ballot in District 3. Her ballot was opened and counted for respondent.
- 22. That in addition to Viola Williams, Johnny B. Thomas, Kenneth Dale Duncan,
  Tiffany Washington and Shirockie Foster are non-residents of District 3, who were allowed

to cast illegal ballots in District 3 for respondent.

- 23. That based upon information and belief several other non-residents of
  District 3 were allowed to cast illegal and unlawful votes on the machine and by absentee
  ballots for respondent during the August 2, 2011, Democratic Primary Election.
- 24. That Jimmie Jones, a voter of Central Greenwood Precinct was assisted by supporters of respondent who illegally marked his absentee ballot for respondent. Jones went to the Central Greenwood Precinct on August 2, 2011, to cast his vote for petitioner on the machine but the poll worker denied him the right to vote and told him he had already voted by absentee ballot.
- 25. That petitioner expressly reserves the right to raise any additional grounds supportive of this election contest which may be revealed by further investigation.
- 26. That as a result of the illegal, wilful violations and fraudulent conduct and acts of commission and omission as stated herein above, respondent was declared the nominee of the Democratic party for Leflore County Supervisor District 3.
- 27. That the fraudulent acts stated herein above invalidates the absentee ballots cast in the August 2, 2011, Democratic Primary Election.
- 28. Alternatively, that the acts alleged herein above show that there were a sufficient number of illegal votes cast or legal votes not counted to change the result or to cast uncertainty upon the result so that the will of the voters cannot be ascertained.

WHEREFORE, Petitioner Preston Ratliff prays that this Petition be received pursuant to Section 23-15-921 et seq. Miss. Code Annotated (1972), that a hearing be held after notice is given to all parties of concern, that the Leflore County Democratic Executive

Committee, after a hearing and investigation of this matter, declare Petitioner Preston
Ratlliff to be the lawful winner of the race for District 3 Supervisor of Leflore County of
the August 2, 2011, Democratic Primary Election. In the alternative, if the committee is
unable to determine who received a majority of the legal votes, and if it finds sufficient
fraud or wilful violations and/or other widespread irregularities occurred casting
uncertainty upon the result then it should order a new election. Further, petitioner prays
for general and equitable relief.
